

The fund has two accumulating share classes (A and I) and one distributing share class (D). In November each year share class D (LU1179404386) pays a dividend to its shareholders amounting to 6% of the NAV of that share class as of 31 October. In November 2019 share class D paid a dividend of 5.51 EUR per share.
