The fund management is subject to an ethical framework and the UN Principles for Responsible Investments, UN PRI.






The fund has two accumulating share classes (A and I) and one distributing share class (D). In May and November each year share class D (LU1179404386) pays a dividend to its shareholders amounting to 3% of the NAV of that share class as of 30 April and 31 October, respectively. In November 2020 share class D paid a dividend of 2.60 EUR per share.
